Welcome to the CaSSOA Autumn Newsletter.

Thank you to those who attended the CaSSOA Annual Meeting at the beginning of September. Karl Knape of RiskSure gave an overview of the survey programme and Robert Barrs delivered an informative presentation on business rate appeals and planning permission.

Key points from the meeting include inviting new Corporate Members from the security industry with a view to offering member benefits, increasing communication with caravan manufacturers to encourage improvements in the security of their products, and encouraging information sharing between members to promote good practice. Marketing, site surveys and the administration of CaSSOA were also discussed. Incident Log

As a matter of good site practice, it is recommended that a log is kept of site incidents. Incidents can include, but are not limited to, crime and anti-social behaviour, as well as accidental damage caused to caravans.

Should you ever need to demonstrate that appropriate action was taken following an incident, an incident report can help to document the steps taken from the time it occured, to conclusion upon completion of investigation.

The following information should be recorded:

- Day/Date/Time of incident.
- Specific location.
- Type of property damaged / stolen.
- State of the damaged property / details of the stolen property.
- Method of entry (if applicable)
- · Details of the offender, or other identifiable features.
- Details of any follow-up action to reduce the risk of repeat
- offence / incident.
- Details of complaint (if applicable).
- Records of correspondance (in the event of a complaint being made).

It is worthwhile considering completing a damage description form for each caravan when it is first admitted onto your site. Any damage to the caravan should be noted and the form signed by both site owner and caravan owner. Damage description forms can prove useful should a caravan owner try to claim that damage was caused to their caravan whilst on site.

Ideally, checks should be made and logged each time a caravan returns to a site, although realistically this may not always be possible.



Please note that CaSSOA should be informed of criminal damage, anti-social behaviour, or fire/flood damage. This helps us to identify patterns in caravan crime, as well as to assist us in keeping comprehensive records about all our member sites. Making us aware of incidents also helps us deal pro-actively should a customer contact us regarding any issues they may have experienced on site.

Member Spotlight

In this issue, we meet Keith and Sarah Strivens of Gatewick Caravan Storage in West Sussex.

How long have you been in operation?

We started storing caravans in 1998. Like many other farmers we were looking to supplement our income, it was basic then - just a row of 10 vans behind a locked gate, and no contract, just working on good will. Over the years the business has grown and we now store 270 vans & motorhomes.



Today we employ 3 part time staff (all family members). As the business grew we soon learned some of the pitfalls and had to address security and portray a professional image. We now have contracts, ask for proof of home address, photo ID and vehicle insurance.

We joined CaSSOA in 2004, this has brought a host of information, not all direct from the office at Nottingham. Attending the annual meetings and talking to other CaSSOA members in our area is always a good source of best practise and as we are all human we learn by our own and others mistakes.

Have you always been in caravan storage?

When I left school in 1977 at 16, I served an apprenticeship as, what was then called a motor mechanic, today you're a vehicle technician, and I've worked on the family farm since I was 21. I also served 32 years as a retained firefighter retiring in 2011.

What do you find most challenging about caravan storage?

One of the most challenging parts is keep the site secure and in the past the biggest challenge was obtaining planning permission to store caravans.

What do you like most about your job?

The better parts are looking back at what has been achieved, having some customers that have been here since day one. Helping customers with small problems, for instance, when the customer is leaving for France, with a ferry to catch, kids are bored with the journey and you can't get all the van lights to work properly it seems like the end of the world. If I can stick my screwdriver in and make them burst into life wishing the customer bon voyage, it puts a smile on my face. The income stream's also very handy.

What do you like to do in your spare time?

In my spare time I like to play with boats - sail or power, I don't care. My wife tells me I'm caravanning on water - it's like a busman's holiday!!

CaSSOA Site Profiles


