

# RiskSure & Site Surveys

- Site Surveys
- RiskSure
- What does a survey provide?
  - Risk identification; theft and vulnerability assessment; full review of the site & facilities security systems.
  - Advice, taking into account local, environmental factors particular to each facility
  - Review of the physical & electronic security systems.
  - Understanding of the sites' risk management protocols & how they would respond to any malicious damage, intrusion or theft incidents.

- A survey report is produced which may include:
  - A review of any loss history, evaluate existing security features.
  - Identify any potential weakness and highlight areas where improvements would mitigate risk.
  - Risk improvements/recommendations.
  - Platinum Award
