Health & Safety Posters

If you employ anyone, the law says you must: display an approved version of the poster, or provide each worker with a copy of the equivalent leaflet

You must display the poster where your workers can easily read it and you can't print a copy yourself.

Seasonal Workers

With many seasonal jobs being filled at this time of year, it is important that employers protect the health and safety of gig economy, agency and temporary workers.

Workers are as likely to have an accident in the first 6 months at a workplace as during the whole of the rest of their working life.

Free CRiS Checks for Cassoa Members

CRiS is the National Register of UK touring caravan keepers, similar to the DVLA and is recognised by the regulatory bodies, insurance companies and government organisations such as the Driver and Vehicle Standards Agency (DVSA) and the Department for Transport (DFT).

As a CaSSOA member, if you have concerns about the ownership of a caravan or want to confirm who the registered owner of a caravan on your site is, you will now be able to get a CRiS check for free.
